याचिका संख्या-251/2011 अशोक कुमार त्रिपाठी एवं याचिका संख्या-3163/2015 डॉ० मातादीन मिश्रा बनाम उ०प्र० शासन व अन्य में मा० उच्च न्यायालय द्वारा दिनांक 01.04.2022 को निम्नलिखित आदेश दिया गया :-

"The petitioner of Writ - A No. 251 of 2011, Ashok Kumar Tripathi v. State of U.P., has already retired on 31.03.2022 while working on the post of Principal. The panel of selected candidates has been produced in sealed cover, which has been opened, does not contain the name of the petitioner- Ashok Kumar Tripathi, therefore, the writ petition is disposed of, as, nothing is required to be adjudicated on merits in this case so far as the relief prayed for is concerned. Consequences shall follow accordingly. The interim order is vacated.

As per the panel of selected candidates Dr. Narendra Bahadur Singh is placed at Serial No. 1, Dr. Rajiv Mishra is placed as Serial No. 2 and Dr. Mata Deen Mishra- the petitioner of the Writ - A No. 3163 of 2015 is placed at Serial No. 3. Accordingly, the result of selection for the post of Principal in pursuance to Advertisement No. 2 of 2008, which was withheld on account of the stay order operating in Writ - A No. 251 of 2011, shall now be declared within a period of one month and thereafter the appointment shall be offered to the selected candidates as per law as early as possible.

Writ - A No. 3163 of 2015 is disposed of in the aforesaid terms. The register, which was produced in sealed cover, is ordered to be put back in sealed cover and the same is returned to Shri Raj Kumar Singh Surayavanshi, learned counsel for the Board who in turn may remit it to the Board.

Both the writ petitions are disposed of accordingly."
