

**Notice Inviting Quotations for hiring of Mobile/Cell Phone/ Bluetooth/
Electronic Device Jammers in the Interviews of UPESSC**

1. Introduction :

UTTAR PRADESH EDUCATION SERVICE SELECTION COMMISSION (UPESSC) is looking for service providers of Mobile/ Cell Phone/ Bluetooth/ Electronic Device Jammers through the use of portable battery operated or plugged in to a standard electrical outlet to block voice/image transmissions of both incoming and outgoing from/to mobile/cell/camera phones/other electronic devices and associated accessories during various Interviews which may be conducted at Commission Campus, Prayagraj.

- 1.1 Last Date and Time for submission of quotation is 22nd Nov, 2024 at 4:00 PM (Offline Mode in sealed envelope to the name of Controller of Examination, UPESSC, Prayagraj).**

2. Scope of Work :-

- 2.1 To supply and install required number of mobile/Cell Phone/ Bluetooth/ Electronic Device Jammers to block voice and image transmissions incoming and outgoing from/to mobile/cell/ camera phones/ at Commission Campus, Prayagraj on the day of Interview on hiring basis.
- 2.2 The agency will have to ensure that the jammers are supplied and installed to block cell phone/bluetooth services at Commission Campus, Prayagraj i.e. CDMA/GSM/3G/4G/5G/Spy Camera/Wi-Fi/Bluetooth.
- 2.3 The agency will have to ensure that the jammers are supplied and installed with or without electric supply for the entire duration of the Interview at Commission Campus, Prayagraj without any technical fault/power failure.
- 2.4 The agency will have to ensure to block the required bandwidth/signals.
- 2.5 The sole responsibility to ensure the jamming of electronic devices i.e. mobile/Cellphone/Bluetooth/Electronic Devices in the Interview Hall will lie on the agency only. The agency will also submit a certificate regarding frequencies jammed during the Interview after completion of the Interview.

- 2.6 The Bidder will be solely responsible to fulfill all the legal requirements, to get NOC/clearance from all the concerned departments what so ever to provide mobile jamming services for the UPESSC.

3. Terms & Conditions :-

- 3.1 The time schedule has to be strictly adhered as the Interview related work is highly time bound.
- 3.2 The Commission reserves the right to reject any or all the tenders without assigning any reasons.
- 3.3 The agency should have adequate infrastructure and deploy required manpower for the successful completion of the assignment as per the above mentioned scope of work.
- 3.4 Any discrepancy or failure to comply the requirement of the Commission in the assignment will be the sole responsibility of the Agency and any lapse will lead to a penal/legal action against the Agency, besides appropriate compensation towards loss occurred to Commission.
- 3.5 The Commission will not be responsible for loss/damages of any equipment installed at the Interview centers and the Agency will be fully responsible for safety and security of its equipment's/infrastructure.
- 3.6 The Agency will be informed the details about the quantum of work and its location in advance adequately. However, the list of Interview centers will be shared only 7 days in advance.
- 3.7 Vendors/Bidders are advised to study the tender document carefully. It will be presumed that the Vendor/Bidder has considered and accepted all the terms and conditions of this tender. No enquiry, what so ever verbal or written shall be entertained in respect of acceptance/rejection of the tender. Bids must be unconditional.
- 3.8 The Bidder should have office or branch in Uttar Pradesh.
- 3.9 The Bids will be rejected in the event of information being found false or detected incorrect or incomplete at any stage prescribed in the tender or any ineligibility being detected, and no correspondence thereof shall be entertained whatsoever.
- 3.10 The Bid Security will be forfeited in the following conditions :-
- (i) If at any stage, any of the information/declaration given by the bidder is found false.
 - (ii) If a bidder withdraws his bid during the period of bid validity specified in the terms and conditions of tender.
 - (iii) In case of any lapse/default in honoring of the terms and

Conditions at any stage after submitting the tender.

- (iv) In case of final selection of bidder, if he fails to enter into contract.
- 3.11 Rate per candidate inclusive of applicable taxes / charges, if any, under any law for the time being in force, shall be quoted in sealed bids.
- 3.12 The bidder has to produce original documents, if any, as and when asked for by purchaser. The failure of bidder to furnish the original documents will entail summary rejection of its tender.
- 3.13 If it is noticed that the unit rates quoted by the Vendor are unusually high or unusually low, it will be sufficient cause for rejection of the quotations unless the purchaser is convinced about the reasonableness of the rates on scrutiny of the analysis for such unit rate to be furnished by the vendor on demand.
- 3.14 The successful vendor has to ensure that no child labour shall be enrolled/employed for carrying out the above work.
- 3.15 All disputes concerning in any way with this NIQ are subjected to Prayagraj jurisdiction only.
- 3.16 The rates quoted should be inclusive of all taxes like Sales Tax, VAT, Service Tax, Octroi etc. No reimbursement of any tax at a later stage will be entertained. Payment of the Bill amount is subject to TDS.
- 3.17 If the Contractor or his workmen or employees shall injure or destroy any part of the building in which they may be working or any building, road, fence, etc. contiguous to the premises on which the work or any part of it is being executed, or if any damage shall happen to the work while in progress the Contractor shall upon receipt of a notice in writing in that behalf make the same good at his own expense.
